Refund Schedule / 退款規則

Terms of Participation Agreement / 協議條款

Application & Booth Fee / 申請程序及攤位租金

Application forms and the full payment must be submitted before July 5, 2025.

Applications that are not fully completed and paid for will not be accepted.

Booths / 攤位

1. Booth spaces will be pre-assigned. The Organizer has the discretion to assign and re-assign booth spaces, so that similar booths are not too close in proximity.

攤位將被預先分配，主辦方有權分配或重配攤位位置，同類型攤位將會分格。

2. The booth space of 10' x 10' area designated by the Organizer is to be used solely for the contracted exhibitor whose name appears on the application form and/or approved by Organizer. Subletting or assigning any rights under this agreement or portions of the rented space without prior written consent from the Organizer would be subject to additional charges or removal from the Carnival area.

3. Exhibitors must comply with all the regulations of the facility host and all Federal, Provincial and Municipal laws and by-laws including health and fire safety requirements.

參展商戶必須遵守聯邦、安省、市政府、主辦方所有條例和附例，包括衛生和防火安全準則。

4. Exhibitors must purchase Commercial General Liability (CGL) insurance and provide proof of such to the Organizer. Insurance requirements will be provided to you once your application has been approved.

商戶必須購買商業一般責任保險 (Commercial General Liability Insurance) 並向主辦方提供保險證明。保險要求詳情將在申請獲批後提供。

5. Food & Beverage exhibitors must have at least one representative who holds a valid Food Handler Certificate present at the booth at all times during the Carnival. Proof of such Food Handler Certificate must be provided to the Organizer.

Hours of Operation / 營業時間

Exhibitors must be open for sales and operation at all times during the Carnival. Failure in doing so may result in penalty and/ or removal from the Carnival.

商戶須在嘉年華期間全時間開放銷售和運營，否則有機會導致罰款和 / 或逐離場。

Selection Process / 評審程序

Jurors look for quality and innovation. Exhibitors with similar products will be limited. Jury members review only the completed applications submitted, and work to achieve our ultimate vision: to create a positive experience for vendors and visitors at our Carnival.

Upon application review, the Organizer will send you an email confirming your approval or denial before August 5, 2025.

Acceptance is determined by the Organizer Federation of Asian Canadians Toronto (F.A.C.T.). Submission of an application does not guarantee a booth. If an application is declined, the full booth fee and deposit will be returned to the exhibitor.

主辦方以產品質素、創新性、和獨特性決定申請結果，同類產品的參展商的數量將受到限制。主辦方只審查完整申請表格。評審的目的是主要為嘉年華的參展商及社區大眾帶來正面，積極的活動體驗。

主辦方將於 2025 年 8 月 5 日前通知攤位申請人的結果。申請接納與否取決於主辦方 Organizer Federation of Asian Canadians Toronto (F.A.C.T.).

Booth Activities / 攤位活動

1. The Organizer has full authority to stop exhibitors from operating should the exhibitor sell or promote products and/ or services other than those stated in the application form.

商戶所售賣或推廣的項目或服務如與申請表上所列名不符，主辦方有權終止商戶所有活動。

2. Exhibitors are not allowed to give away any food or beverage in any format.

商戶不得以任何形式贈送食品或飲料。

3. Exhibitors and their representatives are prohibited from soliciting, selling and promoting their products or services, displaying products or placing furniture, signage and decorations outside of their assigned space.

商戶及其代表禁止在攤位範圍以外兜售、推銷或宣傳其產品或服務、擺設裝置、傢俱、銷售品等等。

4. Sound devices, music and/or motion pictures are restricted to within exhibitor's booth and must be kept below annoyance level as decided by the Organizer. No flashing lights are permitted.

影音設備僅限於商戶的攤位內，且保持在不干擾別人的水平以下。不允許使用閃光燈。

5. No exhibitor shall sell or distribute any form of helium-filled balloons.

商戶不得出售或分發任何形式的氦氣球。

6. No religious items of any form can be distributed on site. 不得在現場分發任何形式的宗教物品。

7. No smoking is allowed in the booths.

攤位內禁止吸煙。

Tents & Electricity / 帳篷 & 電源

Exhibitors who bring their own tents must install enough counterweights to secure the tent from wind.

Exhibitors must provide their own electric generators and outdoor extension cords and power strips.

Cleanup & Breakdown / 清潔和撤場

All goods, tents and display items must stay in place until the end of the Carnival.

Exhibitors must dispose all own trash and recyclables.

No liquid can be poured down the rain drainage.

Exhibitors who fail to properly dispose unwanted items and clean their area will result in monetary penalty.

所有貨物、帳篷和展示物品必須留在攤位內，直至嘉年華結束為止。

Grounds Security / 場地保安

The Organizer provides overnight grounds security for the Carnival area. Please keep equipment, products and valuables under personal supervision before and during the event. The Organizer, Venue and Security are not responsible for any losses or damage.
